4. FIRST AID MEASURES

Swallowed

If swallowed, do NOT induce vomiting. Rinse mouth and give a glass of water to drink if person is conscious. Get medical attention.

Skin Contact

If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If irritation persists get medical attention.

Eye Contact

Hold eyelids apart and flush the eye continuously with running water. Continue flushing for at least 15 minutes. Remove contact lenses if present and easy to do, after the first 5 minutes and continue rinsing. Get medical attention if irritation persists.

11. TOXICOLOGICAL INFORMATION

Acute Effects

Ingestion

The ingestion of large quantities will cause adverse central nervous system effects. Sypmtoms include excitation, euphoria, headache, dizziness, drowsiness, blurred vision, fatigue, tremors, convulsions, loss of consciousness, coma, respiratory arrest and death. Severe intoxication may cause hypoglycemia and hypothermia. Other possible effects are decreased blood pressure, vomiting and blood discharges.

Eye Contact

This product as liquid or vapour, may be irritating to the eyes resulting in tearing and redness.

Skin Contact

This product can be irritating to the skin. Prolonged or repeated exposure may result in redness, itching, swelling. A small proportion of the population may develop and allergic reaction.

Inhalation

Vapours moderate irritating to respiratory tract and mucous membranes. Inhalation may cause symptoms of headache, nausea and vomiting. High concentrations may lead to adverse central nervous system effects.

Chronic Effects: Methanol is identified as a possible reproductive/development toxicant. Methanol is only slowly eliminated from body so should be regarded as a cumulative poison which cannot be made non-harmful.

Other Health Effects Information: Principal routes of exposure are by inhalation of vapour and skin contact/absorption. Persons with pre-existing liver, skin and respiratory disorders may be at an increased risk from exposure. Ingestion of alcohol by pregnant women is associated with foetal alcohol syndrome in babies.


