Skin Contact

If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If irritation persists, get medical attention.

Eye Contact

Hold eyelids apart and flush the eye continuously with running water. Continue flushing for at least 15 minutes. Remove contact lenses if present and easy to do, after the first 5 minutes and continue rinsing. Get medical attention if irritation persists.

Inhalation

Move the victim to fresh air immediately. Keep warm and rest until recovered. Get medical attention if symptoms continue. Begin artificial respiration if breathing has stopped. Get immediate medical attention.

5. FIRE FIGHTING MEASURES

Extinguishing Media:

Use dry chemical powder, foam, polymer foam, and water spray or fog type extinguishers. Water may be ineffective on fire. However, water spray may be used to extinguish fires and to absorb heat. Keep containers cool and protect exposed material. If a leak or spill has not ignited, water spray may be used to flush spills away from exposures.

6. ACCIDENTAL RELEASE MEASURES

Emergency Precautions:

Stop leaking if safe to do so. Do not let products reach drain or waterways; advise the Environmental Protection Authority or your local Waste Management.

Methods and Materials for Containment and Clean Up:

Soak up spilled product using absorbent, non-combustible material such as sand or soil. Avoid using sawdust or cellulose. When saturated, collect material into suitable, labelled, dry, sealable containers and hold for safe disposal. Once pick-up is complete, flush spill site with plenty of water to eliminate any residue. Hold contaminated water for treatment/disposal.

7. HANDLING AND STORAGE

Handling:
